On listed date and time this Officer (Bailey #2386) was working unit 640c-3-5 with Officer Leroux #2260. This unit was working a traffic special with unit 605 (Sgt. Frederick #2123). Sgt. Frederick was using a Laser and targeting speeding vehicles traveling eastbound on Dorr, east of Upton and west of Smead. This unit was positioned about 100 yards east of Unit 605 next to a large brick building and was unable to view any oncoming traffic on Dorr street until auto passed in front of our location. Unit 605 gave a description of a black Dodge Durango traveling eastbound at 50mph in a 35mph zone. As the black Durango passed this units location, we pulled in behind listed vehicle and initiated a traffic stop at Dorr/Smead. This unit contacted communications and gave them the plate of Ohio passenger [REDACTED] (Top # [REDACTED]). Before exiting patrol vehicle we entered the same Ohio license plate [REDACTED] into our MDT. I then approached the driver of the vehicle with Officer Leroux taking a tactical position on the passenger side of the vehicle. I asked the driver for his driver's license and the driver complied handing me his Ohio driver's license. I observed the name "Samuel Wurzelbacher" as being the name of person on the Ohio driver's license and as being the person driving vehicle. I recognized the name and informed Officer Leroux who we had stopped. Officer Leroux instructed Mr. Wurzelbacher why he was stopped and was given a verbal warning and released. This unit gave warning because of ongoing investigation of the Toledo Police Department involving Mr. Wurzelbacher and felt issuing a citation could have negative repercussions to the department and city as a whole. This officer immediately notified 605 and unit 301 (Lt. Ramirez #1696) of who was stopped and why. This unit then contacted communications and gave a disposition of David 11 and returned to position to assist unit 605.
